MARKETING/ADVERTISING TERMS AND CONDITIONS

The undersigned hereby accepts all terms and conditions related to marketing and advertising with the Africa Conference Directory as set out in this order/agreement. The undersigned hereby acknowledges that he/she has the necessary authority to bind the entity named herein to this order/agreement.

A. Membership

1. Membership is for a 12-month period from the date of signing of the membership agreement.
2. Membership cannot be cancelled during a 12-month membership cycle.
3. Should a member attempt to cancel membership prior to the end of the 12-month cycle, the full membership fee will become due and payable on demand, less any payments already received.
4. Membership benefits, fees and payment terms will be as per the signed membership agreement and as governed by the terms and conditions.
5. EON reserves the right to alter, amend or discontinue membership benefits from time to time.

B. Web, Mobile App, Blog, Social Media

1. Acceptance of an order shall only occur once The Africa Conference Directory (Pty) Ltd ("ACD") have duly considered and approved the order. A 50% non-refundable deposit is due and payable upon signing the order form and acceptance by The Africa Conference Directory, unless a special arrangement has been agreed to and is reflected on the signed order form.
